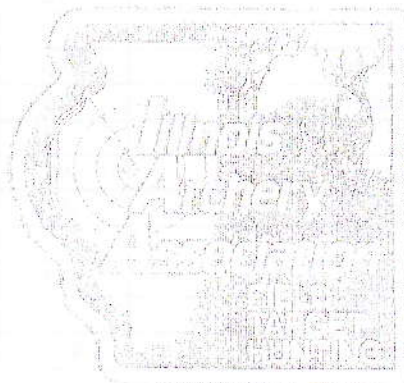
Vote count for this year will be determined by the number of NFAA members listed at NFAA headquarters.
