The IAA board of Directors meeting was held November 6, 2011 at Prairie Archery in Virden following lunch. The meeting was called to order at 1PM by the board Chairman, Dave Woods.

Roll call of officers was taken with the following present, Chairman, Dave Woods; NFAA Director, Judy McCutcheon; central board, Mike Lantz and Bill Mohn; southern board, Bill Schuh, Ron Whitlock and Robert Rayhel, and NFAA Councilman Robert McCutcheon. Also attending was Attorney Matt Schuh and Sara Rayhel.

The minutes of the last meeting was passed out to the board members in advance and Mike Lantz made a motion, 2nd by Ron Whitlock to accept as published.

The financial statements were discussed and Mike Lantz made a motion to accept, 2nd by Ron Whitlock

Bill Schuh gave a report on the gun raffle, stating the number of tickets sold and the amount of money received. Bill's updated report will be published in the bulletin. A discussion was held on when and where the drawings will take place. The board decided that Bill has the tickets and will be responsible for the monthly drawing. He will draw the 1st or 2nd Tuesday of the month with a witness and both will sign the ticket. Bill Schuh made a motion to pay up to \$15 dollars for the transfer fee of the gun, with Ron Whitlock 2nd. Tickets sale will continue until all of the tickets are sold. A discussion was held on some awards and prizes that could be given.

Attorney, Matt Schuh was present and answered some question about our organization.

Bill Mohn suggested that we set up a booth at the state fairs and etc.

There was no report from the Youth, RIC, and Constitution committee.

The awards committee suggested that we give certificates at the state shoots, then have the winners pick up plaques at the convention with names on them to make them more personal. This could also list all of the awards won for that year. This will be discussed at the convention.

The Bowhunting and Conservation committee reported that they only had 2 teams signed up for the whitetail team hunt.

The convention committee reported that the convention will be held March 4, 2012 at the Ryan Steakhouse in Springfield. The charge for the convention meal will be \$15.00.

The Membership and Club Retention committee reported that we need a brochure for the organization and Bill Mohn and Bob McCutcheon will work on getting a brochure together.

Chairman, Dave Woods made the committee appointments and added raffle to the membership and club retention committee.

After discussion, Judy McCutcheon made a motion, 2nd by Ron Whitlock for Robert Rayhel to represent the IAA on the Conservation Congress. Motion carried.

Judy McCutcheon reported that USA Archers suggested that we share shoot dates and put on the web site. The board agreed to do this unless they fell on our state tournament dates.

A discussion was held on the NASP Championship shoot. This event will be held March 24 in the Orr building at the Illinois State Fairgrounds in Springfield. Robert Rayhel had some discussion on this event. Set up will be Friday before and help will be needed. The board voted to have a challenge as before for bows to be given away. Anyone interested should contact Robert Rayhel before Feb. 15th. The IAA will match each bow with ½ dozen arrows.

A discussion was held on the State Championship shoot and Ron Whitlock made a motion 2nd by Robert Rayhel to award the bid to Kishwaukee.

There were no NFAA agenda items to discuss and Ron Whitlock made a motion, 2nd by Mike Lantz to allow \$500.00 to the Director for expenses.

The meeting was adjourned at 3:15PM.

IAA Fund Raiser Update for November

Note: PLEASE GET ALL SOLD TICKET STUBS TO ME ASAP. THE FIRST DRAWING WILL BE DECEMBER 6TH. If you have UNSOLD tickets, hang on to them. Read below for details about them.

As the main ticket selling phase of the raffle winds down, I and the rest of the board want to express appreciation to all who have helped with this fund raiser. So far, a total of 44 members have turned in ticket stubs and money. A total of 1270 tickets have been sold for \$19,050. There have been 27 members who sold 10 or more tickets and, so far, Bill Mohn is high ticket salesperson at 263 tickets sold; a special thanks to Bill for an outstanding effort!

As you may have noticed I used the words “so far” a couple of times. Even though the drawings for guns or cash will begin soon, the board decided at the last meeting that everyone who has unsold tickets should keep selling them until they are gone. Just be sure to have the SOLD ticket stubs to me for the next upcoming drawing which is to be on the first Tuesday of each month beginning in December 2011.

Some people will still pay \$15 for tickets on guns but maybe some people will not want to pay the full price. If people don't want to pay the full price for tickets since they will be missing out on some drawings, then you can discount the price by \$1.25 for each drawing they have missed. This amount will be as fair for them as for those who paid \$15 for 12 raffles because \$15 divided by 12 raffles is \$1.25 per raffle.

Again, if you have tickets cannot sell, you can return them to me and I will get them to people who might be able to sell them.

As we move into the drawings phase of the fund raiser, here is how it will work. The Board decided since I have the ticket stubs I should handle the drawings. The drawings will be on the first Tuesday of each month. If I am not available that day, then the drawing will be as soon as I am available after that date. I am to have a witness present who does not have any ticket stub(s) in the drawing. I will have the witness draw out the winning ticket for that month. The witness and I will sign and date the back of the ticket stub and put it back in with the rest of the tickets for the remainder of the drawings. The winner will be contacted and asked whether they want the gun or the cash. If the winner wants the gun we will get them in touch with our FFL dealer who is helping us with the gun purchases and registrations. If the winner wants cash a check will be sent to them.

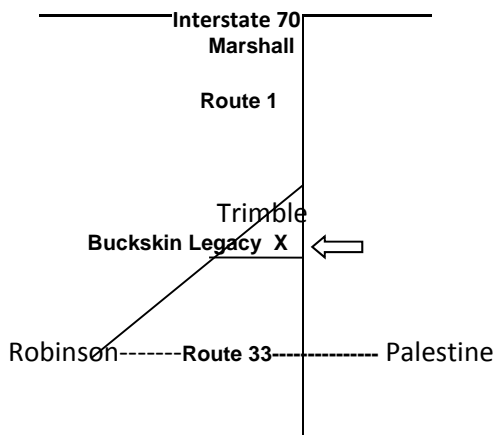
