SECRETARY REPORT - SUMMER BOARD MEETING:

The IAA Board of Directors meeting was held August 25, 2012 at Panther Creek Bowhunters Archery Range following the State Field Championship. The meeting was called to order at 3:09 PM by the Board Chairman Dave Woods.

Roll call of officers was taken with the following present, NFAA Director, Judy McCutcheon; northern board, Rick Knorr; central board, Mike Lantz, James Anderson and Bill Mohn ; southern board, Bill Schuh, Ronald Whitlock and Robert Rayhel.

The minutes of the last meeting was passed out in advance and Jim Anderson made a motion, 2nd by Ron Whitlock to accept as published. The financial statements were discussed and Ron Whitlock made a motion, 2nd by Bill Schuh to accept as printed.

Bill Schuh report that the guns in the raffle were not always available, and that all of the winners took the gun instead of the cash. Bill Mohn reported that a 4-H instructors class will be held the last weekend of September.

There was no report from the convention committee, but was noted that Ryan Steakhouse had closed and we need to work on another place. March 10,2013 was set as the date for the convention. The awards committee will discuss some awards at the November meeting.

A discussion was held on the indoor championship and the date was set for March 2 and 3, 2013. Indoor championship bids were received from Kishwaukee and Buckskin Legacy. Robert Rayhel made a motion, 2nd by Jim Anderson to waive the rule of clubs hosting the event 2 years in a row for this year only. Buck Skin Legacy won the bid with the 75/25 bid, 75% to the IAA and the 25% to the club. Other date set were the sectional on February 23-24, 2013 to be held at CBH in Chicago and Buckskin Legacy in Robinson. The NFAA Nationals will be held March 16 and 17, 2013.

A discussion was held on moving the target championship to June 1 and 2 or June 29 and 30, because of the weather and not having a shoot in June. Judy will write something up to be printed in the bulletin to see what the members ideas were.

A request was received from Armstrong School Archery Program to be a sponsor when they travel to the world Archery Shoot. Robert Rayhel made a motion, 2nd by Mike Lantz to send them \$150.00 from the youth fund. Motion carried.

Robert Rayhel made a suggestion, followed by a discussion that the IAA reimburses Judy McCutcheon for expenses to attend the state shoot if she has to stay overnight. Jim Anderson made a motion, 2nd by Mike Lantz to pay \$100 per night for state shoots. Motion carried.

A discussion was held on a fund raiser for next year. Robert Rayhel will get prices for a new trailer for the IAA targets and it was noted that the door on the present trailer needs work. A discussion will be held at the November meeting.

Jim Anderson made a motion, 2nd by Ron Whitlock to adjourn. The meeting adjourned at 4:26PM
