The IAA Board of Directors meeting was held June 29, 2013 at Pekin Archery Range following the State Target Championship. The meeting was called to order at 2:45 PM by the Board Chairman, Dave Woods.

Roll call of officers was taken with the following present. NFAA Director, Judy McCutcheon: northern board, Rick Knorr and Tim Ward; central board, Mike Lantz, James Anderson and Bill Mohn; southern board, Ron Whitlock and Robert Rayhel.

The minutes of the last meeting was passed out in advance and Jim Anderson made a motion, 2nd by Mike Lantz to accept as published. The financial statements were discussed and Jim Anderson made a motion, 2nd by Mike Lantz to accept as printed.

Dave Woods reported that the trailer has been stocked with bows and arrows and were waiting on the bales.

A discussion was held on the shooters award. This plaque will be in the shape of the State of Illinois, and will be awarded at the convention in 2014.

Dave Woods reported that the constitutional change passed with a vote of 43 Yes and 3 no votes. Judy McCutcheon made a motion, 2nd by Robert Rayhel that no club can host 2 state championships in the same year unless no other bids. This is a change in the by-laws.

Judy McCutcheon, chairman of the awards committee reported that she will order medals and patches.

The convention committee had no report, but March 2, 2014 was set as the date for the convention and it was voted to hold it at the Motel 66 again this year.

Robert Rayhel, Chairman of the bowhunting committee reported that several new laws would go in effect on July 1.

The tournament committee reported that the Indoor Sectional would be held at Joliet Archery and Buckskin Legacy on February 22& 23 and the Outdoor sectional will be held June 21 and 22 in Indiana. The Indoor championship will be held March 8 and 9, 2014. The Indoor National will be held in Louisville on March 14, 15, 16.

Dave Woods reported the officer that would expire this year. Jim Anderson suggested that we get someone to do the backup e-mailing of the bulletin. Judy will contact someone that she knows to see if available.

Jim Anderson made a motion, 2nd by Mike Lantz to adjourn. The meeting was adjourned at 3:25 PM.

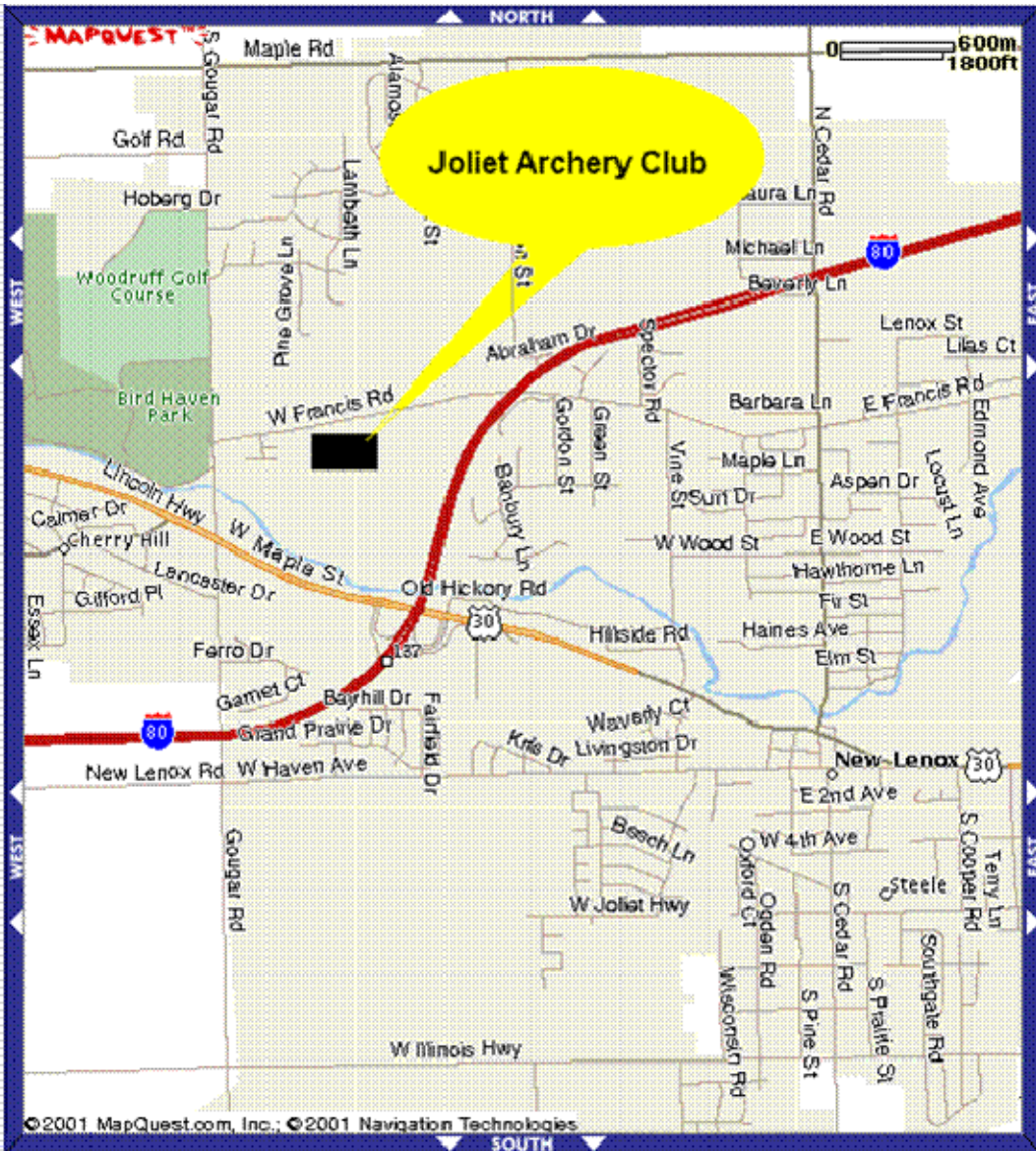
