The IAA Board of Directors meeting was held June 14, 2014, at Scheels Sporting Store, following the target Championship. The meeting was called to order at 4:45 PM by the Board Chairman, Robert Rayhel.

Roll call of officers was taken with the following present, NFAA Director, Judy McCutcheon-Adams; northern board, Rick Knorr; central board, Bill Mohn; southern board, Bill Schuh, Ron Whitlock and Tim Eller. Several other IAA members were attending.

The minutes of the last meeting were passed out in advance and Ron Whitlock made a motion, 2nd by Tim Eller to accept as published. The financial statements were discussed and Tim Eller made a motion, 2nd by Rick Knorr to accept as printed.

A discussion was held on a central location for the state shoot. Chairman, Robert Rayhel reported on the site that he had checked. A discussion was held on combining the state and sectional shoots. Robert Rayhel and Randy Rutledge made suggestions for holding the shoots. They are to make a bid and send back to the tournament director, Judy McCutcheon-Adams. A special meeting will be held after the State Field shoot to go over the bids.

A discussion was held on holding a 900 round the last weekend of March, open to everyone. A committee was appointed to arrange the shoot. Committee members will be Tim Eller, Randy Rutledge, Robert Rayhel and Ron Whitlock, and they will report back at the meeting in August.
