The definition of PRO Senior Division and Pro Silver Senior age groups does not specifically define the upper limit of age for Pro Senior and Pro Silver Senior. This causes confusion because a Pro Senior may determine they are eligible to compete as a Pro Silver Senior or Pro Master Senior and a Pro Silver Senior may think they are eligible to compete as a Pro Master Senior.

The age groups are currently defined below:

The Professional Division shall have the following designation for Senior Professional levels: **A Senior Division for archers ages 50 and older, a Silver Senior Division for archers age 60 and older**, and a Master Senior Division for archers age 70 and older shall be provided at National and Sectional (Indoor and Outdoor) tournaments. **Any archer may compete in only one Division; however, those age 50 and older may compete as either an Adult or Senior, those age 60 and older may compete as either an Adult, Senior or Silver Senior**, and those age 70 and older may compete as either an Adult, Senior Silver Senior, or Master Senior. Silver Senior and Master Senior Divisions shall not seek contingency support, shall not seek guaranteed prize funds (only shoot for entry fees), nor shall they seek awards more than Medals. **RATIONALE:** (Describe briefly existing problem and expected benefit of proposed change)

On March 5, 2010, in response to an inquiry on the use of wraps on arrow shafts by the Indiana NFAA Director, the Rules Interpretation Committee (RIC) issued the following ruling: "RIC 2010-4 The use of wraps on arrow shafts, increasing the arrow shaft diameter beyond 0.422 inches would be **legal** as long as the wrap is not in the scoring area of the target. Arrows penetrating the target scoring area to the wrap would need to be reshot".

At the February 5-6, 2012 NFAA Board of Directors Meeting, the NFAA State Directors voted to **uphold** RIC 2010-4. A motion by the NFAA State Directors to include this RIC ruling in the NFAA By-Laws was never made.

The NFAA Council unanimously agrees that an "arrow wrap rule" is needed in the NFAA By-Laws, similar to the new tournament rule that was added to the February 2019 "Vegas Shoot".  
*If the arrow wrap, nock, or nock adapter exceed 0.422 inches in diameter and are embedded in the scoring area of the target, the arrow shall NOT be scored and will be reshot.*

- Each club or shop can only hold one (1) sectional location
- State associations cannot be a club and cannot be named as the host of a NFAA sectional event

Normal time per arrow is 40 seconds in international competition, and our indoor ends tend to be finished by at least 3 ½ minutes. 40 seconds times 5 = 200 seconds divided by 60 per minute comes to 3 minutes and 20 seconds. Recommend the time limit for the indoor round be changed to 3 minutes and 30 seconds (3 ½ minutes)

**RATIONALE:** (Describe briefly existing problem and expected benefit of proposed change)

NFAA currently does not have a Barebow Recurve class that is compatible with USAA or World Archery Barebow rules like it has with Freestyle and Freestyle Limited Recurve classes. Because of this the NFAA isn't taking full advantage of the outstanding resurgence and growth that has been happening in the Barebow Recurve community over the past 10 years. The benefit the NFAA would have is an even higher membership and more attendees at the national events. For example, the Vegas Shoot introduced a Barebow Recurve class in 2019 and had an incredible first year turnout of 150 archers!

It is recognized that there is a concern that adding a new class doesn't always result in an increase in membership or National and Sectional attendance, because of this, it is proposed that this proposal will be for a trial period of two voting terms.

NFAA Barebow Recurve:

1. This style of shooting is for those who wish to compete with the Recurve or Longbow.
2. Archers shooting Barebow Recurve style will use bow, arrows, strings, and accessories free from any sights, marks or blemishes that may be used as a sighting aid. No laminations, marks or blemishes on the face of the bow or in the sight window will be legal. Multi-colored bow risers, and trademarks located on the inside of the upper and lower limb or on the riser are permitted.
3. An arrow rest and cushion plunger are permitted. There shall be no device, mechanical or otherwise, in the sight window except the arrow rest, arrow plate or plunger button.
4. No clickers, draw checks or levels will be allowed.
5. Weight(s) may be added to the lower part of the riser. All weights, regardless of shape, shall mount directly to the riser without rods, extensions, angular mounting connections or shock-absorbing devices.
6. The unstrung bow complete with permitted accessories shall be capable of passing through a hole or ring with a 12.2cm inside diameter +/-0.5mm.
7. The string may be of any color but must have a single color center serving. Brush buttons and string silencers, properly placed, may be used.
8. One consistent nocking point only is permitted and may be held by one or two nock locators.
9. Face walking and string walking are allowed.

10. Gloves, tabs or fingers shall be the only legal releases. Marks or lines may be added directly to the tab and shall be uniform in size, shape and color. In the case of physical disability of the arms or hands, a chew strap may be used in place of fingers.
11. All arrows shall be identical in length, weight, diameter and fletching with allowance for wear and tear.
12. No written memoranda will be allowed.
13. No part of the arrow rest, cushion plunger or arrow plate may extend more than 1/4 inch above the arrow in the sight window.

a. A bow of any material, which can be either an one piece bow or a bow that can be taken down in two parts and put together again as a one piece bow within the handle (only shared once in the handle), which when strung displays one continued unidirectional curve, which is measured as follows:

When the strung bow is placed with the bowstring in a vertical position, the angle as measured between the tangent of any point on the limb and an imaginary horizontal line must always decrease as this point is moved further away from the bow grip. Where there is any doubt as to the continuing curve of the limb then a string-line laid from the end of the riser fade out to the commencement of the tip overlays (or if there are no overlays then the point at which the bow string is held in the nock groove) on the back of the strung bow shall show no gaps between the string line and the bow limb.

b. The tip reinforcing may not exceed 20mm in height, measured from the surface of the back of the bow limb and may not exceed 50mm in length, measured from the centre of the string groove towards the bow grip.

c. The bow may contain a window and an arrow shelf. The side of the window shall be slanted over the full length of the window and rounded off at the point where the window intersects with the top bow limb. The window cut may not exceed the centre of the bow.

d. The belly, bow grip, the window and the arrow shelf shall be free of any marks or blemishes that may be used as sighting aids. If such blemishes or markings are present on the window of the bow riser, the full length of the back of the window shall be covered with tape.

e. Any additions to the bow for the purpose of stabilisation, levelling, draw-weight reduction, sighting and/or draw checking are not permitted

f. Only one nocking point shall be allowed on the string, which may be marked by either one or two nocking point locators. If resting nocks are used -such as ball nocks -only one locator may be used.

g. String silencers no closer than 30 cm above or below the nocking point are allowed.

h. Arrows shall be of wood, fletched with natural feather, and must be of the same fletch and pile, without regard for colour. The arrows must be free of any marks or blemishes that can be used as sighting aids and shall not vary in length by more than 25mm at the start of the competition. Nocks may be of any material and any weight of pile may be used.

i. The bow must be shot with the "Mediterranean" loose. In cases of physical deformity or handicap special dispensation shall be made.

j. You are permitted to walk your face.

k. Only the adult division shall be recognized

NFAA By-Laws, Page 35-36, Article III (Divisions of Competition), Section D (Professional), Paragraph 1 (Membership), Item 1.7, states the following:

The Professional Division shall have the following designation for Senior Professional levels: A Senior Division for archers ages 50 and older, a Silver Senior Division for archers age 60 and older, and a Master Senior Division for archers age 70 and older shall be provided at National and Sectional (Indoor and Outdoor) tournaments. Any archer may compete in only one Division; however, those age 50 and older may compete as either an Adult or Senior, those age 60 and older may compete as either an Adult, Senior or Silver Senior, and those age 70 and older may compete as either an Adult, Senior Silver Senior, or Master Senior. Silver Senior and Master Senior Divisions shall not seek contingency support, shall not seek guaranteed prize funds (only shoot for entry fees), nor shall they seek awards more than Medals. (Silver and Master Pro divisions are exempt from Silver Bowls.) The only recognized Divisions shall be Freestyle Men and Freestyle Women for Silver Senior and Master Senior.

It is our opinion that the above paragraph **does not** provide a "level playing field" for **all** the Professional Divisions. The intent of this Agenda Items is to make **all** the Professional Divisions equal, whereby:

The Professional Silver Senior and Master Senior Division Champions shall receive Silver Bowls.

The Professional Silver Senior and Master Senior Divisions **should not** be prevented from seeking and receiving contingency support or guaranteed prize funds.

**RATIONALE:** (Describe briefly existing problem and expected benefit of proposed change)

The NFAA currently does not have a Barebow Recurve Style of competition that is compatible with USAA or World Archery Barebow rules like it has with Freestyle and Freestyle Limited Recurve Styles. Because of this, the NFAA isn't taking full advantage of the outstanding resurgence and growth that has been happening in the Barebow Recurve community over the past 10 years. The benefit the NFAA would have is an even higher membership and more attendees at the national events. For example, the Vegas Shoot introduced a Barebow Recurve Style of competition in 2019 and had an incredible first year turnout of 150 archers!

It is recognized that there is a concern that adding a new Style doesn't always result in an increase in membership or National and Sectional attendance. Because of this, it is proposed that this Agenda Item will be for a trial period of TWO (2) NFAA Board of Directors' Bi-Annual Meetings (revisit in 2023).

I Barebow-Recurve:

1. This style of shooting is for those who wish to compete with the Recurve or Longbow.
2. Archers shooting Barebow Recurve style will use bow, arrows, strings, and accessories free from any sights, marks or blemishes that may be used as a sighting aid. No laminations, marks or blemishes on the face of the bow or in the sight window will be legal. Multi-colored bow risers, and trademarks located on the inside of the upper and lower limb or on the riser are permitted.
3. An arrow rest and an adjustable cushion plunger are permitted. There shall be no device, mechanical or otherwise, in the sight window except the arrow rest, arrow plate or plunger button.
4. No clickers, draw checks or levels will be allowed.
5. Weight(s) may be added to the lower part of the riser. All weights, regardless of shape, shall mount directly to the riser without rods, extensions, angular mounting connections or shock-absorbing devices.
6. The unstrung bow complete with permitted accessories shall be capable of passing through a hole or ring with a 12.2 cm inside diameter +/-0.5mm.
7. The string may be of any color but must have a single-color center serving. Brush buttons and string silencers, properly placed, may be used.
8. One consistent nocking point only is permitted and may be held by one or two nock locators.
9. Face walking and string walking are allowed.
10. Gloves, tabs or fingers shall be the only legal releases. Marks or lines may be added directly to the tab and shall be uniform in size, shape and color. In the case of physical disability of the arms or hands, a chew strap may be used in place of fingers.

11. All arrows shall be identical in length, weight, diameter and fletching with allowance for wear and tear.

**RATIONALE:** (Describe briefly existing problem and expected benefit of proposed change)

Along with the explosive growth and exposure of competitive archery comes the desire for archers to capitalize on their talents and for companies to advertise the attendance and performance of their shooters in a bid for personal and brand recognition. This is typically done through the use of "Pro Staff's". It is a textbook example of a cross promotional relationship for the company and the archer. It goes without saying that archers will always have an incredibly strong desire to be on as many "Pro" Staff's as possible as they build their resume to market themselves to other manufacturers. It then follows that manufacturers seek archers who are a part of many "Pro" Staff's as it generally adds credibility and stature to their respective teams. Over the years it has led to a disingenuous and inappropriate use of the term "Pro".

This attachment of the word "Pro" has been casually added to those teams and archers with unintended consequences that are detrimental to the actual Professional Archer and the Professional Divisions. When used improperly it devalues the definition, the brand, and the integrity of a Professional Archer. It can make it more difficult for the true Professional to earn contracts against those who are not actually a Pro but using the term. It can artificially devalue the financial investment the manufacturers and sponsors are putting into the true Professionals and Professional archery. If almost anyone can be part of a "Pro Team" without registering and competing as a Professional in the highest divisions then what value is there in having a Pro Staff Program focused at the highest level? As we continue to move into the broadcast arena of our sport, this will increase the value of the Professional division and the desire to be in it.

Additionally, and probably most importantly In the NFAA we as Professionals are constitutionally bound to protect the status of the amateur archer. (See: Code of Ethics page 36 Section 2 Para 2.4) Allowing archers who are not registered Professional competitors to wear and use the term Pro flies in the face of that mandate and our constitutional requirements.

At the last meeting, the BOD agreed to implement a minimum qualification score for incoming (new) Professional archers. In my initial rationale it was my desire to support the 3 main NFAA Sectional and National events by requiring scores from the Blue Face or Field Round or the Hunter Round. – The new proposal allows more options for scores to be used as a qualifier. It has become apparent that many states use the Vegas style faces in various scoring formats for their events. Additionally, the NFAA has other National rounds that should be considered to encourage Pro growth and participation especially in the western and central parts of the country. With this change I hope to add more NFAA Sanctioned rounds to the qualification list to accommodate more shooters with more opportunities to qualify.

NFAA currently does not have a Barebow Recurve class that is compatible with USAA or World Archery Barebow rules like it has with Freestyle and Freestyle Limited Recurve classes. Because of this the NFAA isn't taking full advantage of the outstanding resurgence and growth that has been happening in the Barebow Recurve community over the past 10 years. The benefit the NFAA would have is an even higher membership and more attendees at the national events. For example, the Vegas Shoot introduced a Barebow Recurve class in 2019 and had an incredible first year turnout of 150 archers!

It is recognized that there is a concern that adding a new class doesn't always result in an increase in membership or National and Sectional attendance, because of this, it is proposed that this proposal will be for a trial period of two voting terms.

1. This style of shooting is for those who wish to compete with the Recurve or Longbow.
2. Archers shooting Barebow Recurve style will use bow, arrows, strings, and accessories free from any sights, marks or blemishes that may be used as a sighting aid. No laminations, marks or blemishes on the face of the bow or in the sight window will be legal. Multi-colored bow risers, and trademarks located on the inside of the upper and lower limb or on the riser are permitted.
3. An arrow rest and an adjustable cushion plunger are permitted. There shall be no device, mechanical or otherwise, in the sight window except the arrow rest, arrow plate or plunger button.
4. No clickers, draw checks or levels will be allowed.

7. The string may be of any color but must have a single color center serving. Brush buttons and string silencers, properly placed, may be used.
8. One consistent nocking point only is permitted and may be held by one or two nock locators.
9. Face walking and string walking are allowed.

10. Gloves, tabs or fingers shall be the only legal releases. Marks or lines may be added directly to the tab and shall be uniform in size, shape and color. In the case of physical disability of the arms or hands, a chew strap may be used in place of fingers.
11. All arrows shall be identical in length, weight, diameter and fletching with allowance for wear and tear.
12. No written memoranda will be allowed.
