The IAA Board of Directors meeting was held July 11, 2009 at the Pekin Archery Range following the target championship. The meeting was called to order at 2PM by the NFAA Councilman, Bob McCutcheon.

Roll call of officers was taken with the following present, NFAA Director, Judy McCutcheon; northern board, Rick Knorr and Walter Erickson; central board James Anderson; southern board Bill Schuh and Ron Whitlock and NFAA Councilman, Bob McCutcheon.

The minutes of the last meeting was passed out to the board members in advance and Ron Whitlock made a motion, 2<sup>nd</sup> by James Anderson to accept as published. The financial statement was discussed and Jim Anderson made a motion, 2<sup>nd</sup> by Rick Knorr to accept as printed.

The next meeting date was announced as November 29, 2009 at Prairie Archery in Virden.

Committee reports were given with the convention committee reporting that the convention will be held at Ryan's steakhouse. The board then set March 14, 2010 for the convention that does not interfere with tournament dates. The awards committee reported that plaques were ordered and needed to order NFAA patches. The bowhunting & conservation committee reported that there was a lack of participation this year. A discussion followed with the decision to advertize with a full page in the bulletin. The constitution and membership and club retention committee had no reports. The youth committee reported that the Department of Conservation will need help with the NASP to be held sometime in March or April. A discussion was held on the phone line used for internet service; having gone wireless Jim Anderson made a motion, 2<sup>nd</sup> by Ron Whitlock to disconnect the phone line. Jim Anderson then made a motion, 2<sup>nd</sup> by Rick Knorr to pay the set up fee of \$150 for wireless service.

Jim Anderson made a motion, 2nd by Ron Whitlock to adjourn. Meeting adjourned at 2:40 PM


