The IAA board of Directors meeting was held November 29, 2009 at Prairie Archery in Virden followed by a potluck lunch. The meeting was called to order at 1:10 pm by the Board Chairman, Dave Woods.

Roll call of officers was taken with the following present, Chairman, Dave Woods; NFAA Director, Judy McCutcheon; northern board, Rick Knorr; central board, William Mohn; southern board, Bill Schuh, Ron Whitlock and Robert Rayhel; and NFAA Councilman, Robert McCutcheon.

The minutes of the last meeting was passed out to the board members in advance with a question on the tournament format, Rick Knorr made a motion, 2nd by Ron Whitlock to accept as published.

The financial statement was discussed. Questions were answered about the income and expenses. Robert Rayhel made a motion, 2nd by Ron Whitlock to accept.

Committee reports were heard with the Awards committee stating that they needed to order plaques but had enough medals. Dave Woods would check on ordering year bars.

The convention committee reported that the convention will be held at the Ryan Steakhouse in Springfield on March 14, 2010. A discussion followed about changing the date to a Saturday and the price of the meal. Ron Whitlock made a motion to have the convention on Sunday with a charge of \$15.00 for the meal, 2nd by Bob McCutcheon. Bill Mohn will check on another place to host the convention with a catered meal or a potluck. Another suggestion was to check out the Golden Coral in Springfield for next year.

There was no report from the constitution, RIC and membership & club retention committees.

A discussion was held from the bowhunting and conservation committee about the big game and team hunt programs. The committee will set up new guidelines and present them at the convention.

The Youth committee announced that the NASP tournament will be held March 27 at the Orr building in Springfield. Help will be needed to set up for the tournament on March 26. A discussion was held on the amount needed for a school to set up a program. The IAA will buy the trophies and give new bows and arrows. Bill Mohn will set up a challenge and send it to the IAA office.

The tournament committee held a discussion on the 3-D rendezvous. The awards were changed to IAA medals instead of plaques. Also noted was a small increase in the number of shooters at the Target Championship with the change from the two day tournament to a one day tournament.

A discussion was held on the CD that the IAA holds. Robert Rayhel made a motion to find the best interest rate for a 15 mo CD., 2nd by Ron Whitlock. A question was made on the balance of the money in checking account. The board decided to leave in checking to cover any unexpected expenses.

A discussion was held on the NFAA director's expense and Robert Rayhel made a motion, 2nd by Rick Knorr to pay the NFAA director \$500 to cover expenses.

New committee members were appointed by the Chairman, Dave Woods.

Tournament committee chairman, Judy McCutcheon reported on the state tournament dates for 2010 to be bid at the convention and this list will be published in the coming events.

After a 15 minute break, NFAA Director Judy McCutcheon reported on the NFAA agenda items and stated the agenda items were on the NFAA web site. Members can check out the agenda items and report back to her. Judy passed out the NFAA raffle tickets to the members present.

Judy McCutcheon made a motion, 2nd by Robert Rayhel to adjourn. The meeting adjourned at 3:35 pm.

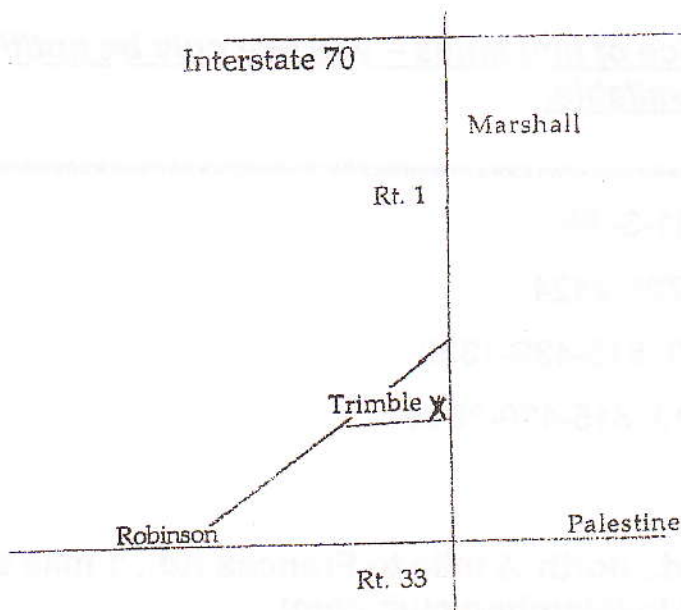
