IAA Board of Directors and the members that were present at the convention in March have decided to hold another Gun Raffle to raise money for the organization. This will enable the organization to do more things to promote itself and the sport that we all love.

Ticket Prices are \$15.00 each and Tickets go on sale late August.

First drawing will be in January of 2015. We have to sell 600 tickets before the drawings will start. If we do not sell at least 600 tickets, it will become a 50/50 drawing.

Guns will not be purchased until after each drawing. Winner may want cash instead of the gun for that month. If the winner chooses the gun, there may be a delay in delivery of the gun due to some shortages from manufacturers, according to the firearms dealer we are working with.

Only 2000 tickets will be printed which will increase the odds of winning. Drawn ticket will go back into the bucket for the next drawing so 1 person has the potential to win all 12 guns for an investment of \$15.00.

Bill Mohn and Bill Schuh again graciously agreed at the convention to administer the raffle for the IAA. Club contacts or members contact Bill Mohn for tickets.

Club contact will distribute tickets to club members. They know the members and can better control tickets and money. Club contact will collect the ticket stubs and \$\$ or checks. Please make checks payable to IAA for amount collected.

Seller puts their name on the back of the ticket stub that they sell. For every 5 stubs that you sell, seller will be put into the drawing for one of five \$100 prizes. Each member needs to turn in their sold ticket stubs by the 15th of the month for the next month's drawing.

Tickets can be sold to non-Illinois residents. IL residents will require a FOID card to accept a gun. Non IL residents will need to make delivery arrangements with their local FFL gun dealer to receive any guns won.

To make this a success, we will need every member's help. The first time we had the gun raffle a few of us weren't sure it would work. I was one of them. These two members and the people who helped sell the tickets more than proved us wrong. The first raffle proceeds enabled the IAA to function for the last 3 years. It's what we used to purchase the State Championship trophies which cost the IAA approximately \$2000.00 for last year (2013). It will be the same for this year (2014). So if this Gun Raffle goes as well as the last one, we can plan to do some more things in the state, like having some bigger shoots and other activities. So please take a few minutes and think about this, then get with either Bill Mohn or Bill Schuh and have them send some tickets to you. We need your help.

Thanks to all who hosted and attended the shoots this year.

Hope to see you all at the State Indoor this winter. It will be held at Sauk Valley Archers in Dixon. Have a good indoor season.

#### IAA Raffle Ticket Selling Tips

1. Contact your local club raffle contact or Bill Mohn to obtain tickets to sell. Bill Mohn, call 217-725-0836.

2. Since the tickets cost \$15, carry a few \$5 bills so you can make change for \$20 bills.

3. Ask friends, family and co-workers if they like guns and gun raffles. If they say "no", then ask them if they like cash. There is a cash option for each raffle if they don't want a gun. Show them the back of the tickets for the list of guns and cash options.

4. Explain that these tickets are for 12 raffles at \$1.25 per raffle. The winning tickets go back in the cage for the next drawing so all tickets are in all 12 raffles.

5. Have the buyer fill out the left portion of ticket so we can contact them. Tear of the right portion of ticket and give to the buyer so they can see what is being given away each month.

6. Be sure to put your name on the back of the ticket stub as IAA member. For every 5 tickets you sell, you get your name entered once for 5 drawings for \$100 each. The more tickets you sell the more chances you have of getting drawn for the \$500 cash. Everyone can sell at least 5 tickets and get in on this drawing.

#### Notes:

Some people may ask how they get their gun if they live out of state. If people live out of state or don't want to pick up their gun at our dealer in Springfield, IL, they can have the gun shipped from our dealer to an FFL gun dealer near them. Then they can pick up their gun at their local dealer.

Some people may ask if they need a FOID to buy tickets. They do not need a FOID to buy tickets. If they are a winner and live in Illinois and want a gun instead of cash, then they will need a FOID. Out of state winners do not need a FOID.

The IAA Board of Directors meeting was held June 27, 2015 at the Pekin Archery Range following the target championship. The meeting was called to order at 3 PM by IAA Chairman, Robert Rayhel.

Roll call of officers was taken with the following present, NFAA Director, Judy McCutcheon-Adams; northern board, Rick Knorr; central board, Roger Nieders; southern board, Tim Eller, Bill Schuh, and Ron Whitlock, and IAA Chairman, Robert Rayhel. Others present were Eddie Flier, Mark Jones, Mike Lantz, Victoria Renaud, Randy Rutledge, Laurie Schuh, and Pat Whitlock.

The minutes of the last meeting were distributed to the board members and Ron Whitlock made a motion, 2<sup>nd</sup> by Roger Nieders to accept as corrected. The financial statement was discussed and Tim Eller made a motion, 2<sup>nd</sup> by Rick Knorr to accept as printed.

In old business, a Triple Crown/Shooter of the Year was discussed. A motion was made by Bill Schuh, 2<sup>nd</sup> by Tim Eller to award 2 Triple Crown shooters for high scoring male and high scoring female for the combined scores of the 3 state championship shoots- State Indoor, State Target, and State Field. Motion passed unanimously. The scoring will begin with the 2016 State Indoor and the award will be presented in 2017.

Committee reports were given stating that the convention will be held at Motel 66 in Springfield. The board then set March 6, 2016 for the convention date. The constitution with the change was distributed with the new item on attendance by board members to start Nov. 1, 2015. The awards committee reported more NFAA patches will be ordered. The bowhunting & conservation committee membership and club retention committee had no reports. The youth committee said the NFAA youth members placed well at the 4-H National competition held in Nebraska this past week. The tournament committee reported the State Field will be held Aug. 22-23, 2015 at Panther Creek.

In new business, a second Bowhunter Jamboree shoot in May or June was suggested. Rick Knorr recommended seeing how the shoot goes in September and then deciding.

Bids were taken for the Great Lakes Indoor Sectional for Feb. 27 & 28. Buckskin and Kishwaukee will host the shoots.

The Great Lakes Outdoor Sectional was held in South Bend on June 11-12. Indiana has one more year to host the event.

The next meeting date was announced as November 1, 2015 at Sheels in Springfield.

Ron Whitlock made a motion, 2nd by Judy McCutcheon-Adams to adjourn. Meeting adjourned at 3:55 PM
